Emergency Safe House and 24 Hour Text/Phone Line: Safe + Sound Somerset provides a staffed 24 hour phone/text line as a means to provide information, education, crisis intervention and community resources for those experiencing domestic violence or dating abuse. The Safe House is a short-term emergency shelter for survivors and their children who are in imminent danger due to abuse in their home. Since 1983, this emergency shelter has been providing services seeking confidential refuge from an abusive living situation.

4b (Code:) (Expenses \$ 143,557. including grants of \$ 0.) (Revenue \$ 0.)
Transitional Program: Safe + Sound Somerset's Transitional Housing Program provides safe, affordable housing to survivors of domestic violence and their children. Individual apartments provide independent, violence-free living options to survivors transitioning out of the crisis shelter. Case Management services, Legal Advocacy, Individual, Group and Children's therapy and counseling are provided to residents to support them as they become self-sufficient in an abuse free environment.

Outreach Programs: The goals of the Outreach Programs are to increase safety, self-sufficiency, coping skills and empowerment for survivors and their children. Safe + Sound Somerset's outreach programs include legal advocacy, case management, and trauma-focused clinical services to assist survivors to regain control of their lives. Safe + Sound Somerset offers innovative cognitive-behavioral therapies for the treatment of trauma and PTSD. Prolonged Exposure (PE) and Trauma Focused Cognitive Behavioral Therapy (TF-CBT) help adult and child victims of domestic violence respectively, to overcome their fear, anxiety, and stress as it relates to their traumatic experience. Clinical services also includes treatment for anxiety, See Part III, Ln 4c statement
